THIRD ORDER OF BUSINESS

**Consideration of the
Minutes of the August 20,

The Board reviewed the minutes of the August 20, 2019 Board of Supervisors Meeting.

On Motion by Ms. Isaacs, second by Mr. Adams, with all in favor, the Board of Supervisors for the Poitras East Community Development District approved the Minutes of the August 20, 2019 Board of Supervisors Meeting.

FOURTH ORDER OF BUSINESS

**Consideration of
Construction Funding
Agreement by and between
the District and TDCP, LLC**

Ms. Mackie explained that the District is in a position where it will start to begin design and construction on its Capital Improvement Plan. This agreement commits the Developer to funding the District’s Capital Improvement Plan until such time as Bonds are issued and then it provides for the reimbursement to the Developer upon the issuance of Bonds.

On Motion by Ms. Isaacs, second by Mr. Adams, with all in favor, the Board of Supervisors for the Poitras East Community Development District approved the Construction Funding Agreement by and between the District and TDCP, LLC, subject to further review by TDCP, LLC’s Counsel.

FIFTH ORDER OF BUSINESS

**Discussion Regarding
Establishment of a
Construction Committee**

Ms. Mackie recommended that this Board constitute a Construction Committee with the same individuals that serve the other Lake Nona Districts.

On Motion by Ms. Isaacs, second by Mr. Adams, with all in favor, the Board of Supervisors for the Poitras East Community Development District appointed a Construction Committee consisting of Larry Kaufmann, Scott Thacker, and Troy Davidson.

SIXTH ORDER OF BUSINESS

Ms. Mackie explained that TDCP, LLC has designed and are engaging contractors for Phase 1A. It is likely the District will acquire that infrastructure from the Developer once it is fully completed. For future phases of the District’s Improvement Plan, District staff would like to prepare the RFQ

for advertisement, receive qualifications from interested contractors, have the Construction Committee review those submittals received and make recommendations to this Board at the December meeting as to which Contractors should be pre-qualified.

On Motion by Ms. Isaacs, second by Mr. Adams, with all in favor, the Board of Supervisors for the Poitras East Community Development District Authorized District Staff to Proceed with Request for Qualifications from Contractors Interested in Providing Construction Services for Master Infrastructure Improvements.

SEVENTH ORDER OF BUSINESS

Consideration of Authorization to Proceed with Request for Proposals for Construction Services Relating to Master Infrastructure Improvements

Ms. Mackie put this on the agenda as a placeholder thinking that the schedule for Phase 1B might not allow for sufficient time to pre-qualify contractors and then process an ITB, but TDCP, LLC has confirmed that the project schedule will allow the District to conclude the qualification process and go out for an ITB for that next phase. Accordingly, no action is requested.
